SUGGESTED MASS SETTINGS AND PROHIBITED HYMNS

Bishop W. Shawn McKnight has approved Mass settings and published a list of prohibited hymns and composers.

The approved Mass settings are included for the purpose of communion throughout the diocese, especially for diocesan liturgies. The intent is not that they are the only settings allowed to be used, but that all should know at least these settings.

In addition, a small number of hymns have been determined by the USCCB Committee on Doctrine to be insufficient in sound doctrine or prohibited based on credible accusations of abuse against the composer. The use of these hymns is prohibited.
