By a Decree of August 11 the S. C. of Rites laid down and declared that the reproductions of the Vatican edition of the liturgical Gregorian books must be entirely conformable to the typical edition, without additions, omissions or changes. By a certain toleration of the Holy See and with the permission of the Ordinary, the said reproductions have sometimes contained certain signs, known as rhythmical, and those reproductions have been published and sold to the public, but several complaints were made that by the selection and adding of these signs the traditional Vatican notes were somewhat varied, and changed, and to remove these abuses the S. Congregation determined to publish the other Decree of February 14, 1906. But as all the abuses did not cease and others were added to those already existing, such as that of the title of rhythmical edition and the wrong interpretation, another authentic declaration became necessary and was given by a Letter of the Secretary of the S. C. of Rites on May 2, 1906. In this letter publishers in possession of the faculty and permission to reproduce the typical Vatican edition were clearly informed that this edition alone was approved by the Apostolic See and prescribed for use in the Gregorian chant together with the subsequent editions fully conformable with it; and that other editions, called rhythmical by reason of the added signs, are to be held as merely tolerated and that in this sense is to be understood the Decree of February 14, 1906.

This being so, in order to remove existing abuses and to preclude the introduction of those that have been referred to and others that might easily creep in, the S. Congregation has determined to decree and declare more clearly the following points:

1. The Vatican edition of the liturgical Gregorian books, as published by Apostolic Authority, with its traditional notes and the rules prefixed to the Roman Gradual, contains quite enough information as to the right execution

of the liturgical chant.

2. The reproductions of this typical edition containing the extra signs, known as rhythmical, are abusively called rhythmical editions and as such have not been approved but merely tolerated upon request; this toleration, under the circumstances, can no longer be admitted except for editions already made of the Gradual and the Office of the Dead, and therefore cannot be at all extended to the editions with Gregorian notes or to extracts, with the same notes, of the Antiphonary and any other books whatsoever and published according to the tenor of the motu proprio of April 25, 1904, and of the Decrees

of this S. Congregation both for the Universal Church and for individual dio-

3. In the meantime the Most Rev. Ordinaries of places and the Superiors of Orders or Congregations may permit within the limits of their several jurisdictions the use of the editions tolerated upon request by the Holy See, but without ordering their use in the places subject to them or prohibiting the use of the approved edition.
