Title: Director of Sacred Music

General Scope

The Director of Sacred Music at Saint Michael Parish is a professional musician who has a thorough understanding of and love for the Roman Catholic Liturgy, including an understanding of both the current Roman Missal and the Missal of Pope John XXIII (1962). The Director reports to and cooperates with the Pastor, sharing and supporting his vision for Sacred Music. The Director also collaborates and works closely with the Parochial Vicar, Pastoral Associate (who coordinates the Sacred Liturgies within the parish), other parish staff members, appropriate committees, and musicians, vocalists, and volunteers to prepare liturgical music according to the mind of the Church as found in her tradition and her instructional documents.

Primary Responsibilities

- 1. The Director serves as the primary musician for the parish. This includes weekend, weekday, holy day, school, and special liturgies and devotions.
 - The Director personally plays at least two Sunday observation liturgies per week, as well as the majority of Holy Days of Obligation services, and four weekday liturgies.
 - The Director personally plays or directs the music at all Triduum services, the Easter Vigil, Ash Wednesday Masses, First Holy Communion Masses, and parish penance services, including First Reconciliation.
- 2. The Director conducts and/or oversees all choirs and ensembles.
 - o Current choirs and ensembles include:
 - the Archangel Choir (the primary choir for Sundays and Solemn Feasts)
 - the Children's Choir
 - the Handbell Choir
 - the Schola Cantorum
 - various ensembles (Lessons and Carols, Tenebrae, Night of Worship, etc.)
 - Special Christmas and Easter choirs
 - Orchestra (Christmas/Easter/special occasions)
- 3. The Director recruits, trains, coordinates, and schedules parish musicians and cantors.
